1. Project Overview

The City of Louisiana is seeking qualified contractors to submit bids for the repaving of three streets: Haley Avenue, Iowa Street, and South Carolina Street, between 25th-30th Street.

2. Scope of Work

The successful vendor shall provide:

- Site Assessment and Preparation
 - o Inspect and document existing pavement conditions
 - Mill existing asphalt/concrete where necessary (depth to be determined by condition)
 - Remove damaged pavement, potholes or unstable base areas
 - Clear and dispose of debris, vegetation overgrowth and loose materials
- Surface Grading and Base Repair
 - o Re-grade areas where base failure is identified
 - o Compact subgrade and place base rock or aggregate where necessary
 - Ensure proper slope for drainage and curb/gutter computability
- Asphalt Paving
 - Apply tack coat where necessary for adhesion
 - Place and compact new hot-mix asphalt to a minimum compacted thickness of 2 inches
 - Ensure smooth transitions to adjacent streets, driveways and intersections

- Traffic and Site Management
 - o Provide appriopriate traffic control signage and flaggers during work
 - Maintain access for emergency vehicles and affected residents during construction
 - Restore any disturbed sidewalks, driveways or lawn edges to original condition
- Cleanup and Final Inspection
 - o Remove excess materials, equipment and waste
 - o Perform a final walkthrough with City personnel
 - o Address any deficiencies prior to acceptance

3. Bid Requirements

Each Bid must include:

- A detailed, itemized cost estimate for all work and materials.
- Proposed start date and estimated project timeline.
- Proof of insurance and applicable licenses.
- References or brief project history demonstrating experience with similar projects.
- Warrant statement for workmanship and materials (if applicable)
